INTRODUCTION

In November 2021 the Board of Directors approved a revised version of the April 2021 Research and Scholarship Strategy that addressed matters raised in TEQSA Guidance Notes on 'research' and 'scholarship' as well as changes to the Higher Education Standards Framework resulting from new Provider Category provisions in that legislation. The original Strategy was implemented in the 2020 Report and Scholarship Report, and the modestly revised Strategy is the foundation of this 2021 Report. A key feature of the Research and Scholarship Strategy is the collection of all publication outputs from ACT faculty into a repository for analysis and public dissemination of summary information.

Publication outputs are classified as 'research' if they are determined to be likely to meet the Provider Category requirement of 'world standard' (in a collective assessment). That is, if submitted to an Excellence in Research Australia (ERA) assessment (or similar process) they would be expected to be collectively judged to be of at least 'world standard'. The ACT Department of Research uses a list of journals and publishers expected to meet ERA peer review of 'world standard' and applies them to publication outputs, as well as reviewing individual outputs. Those that meet the above criteria are categorised as 'research.' The ACT list of journals reflects a similar list developed by the <u>Council of Deans of Theology</u> of Australia.

Other publications are considered as 'confessional scholarship,' in that the focus of the publication is scholarship that contributes to the life of the Church – see the Research and Scholarship Strategy for further discussion. Confessional scholarship books, book chapters and journals are academic publications and subject to typical refereeing processes.

The results of applying the 'research' and 'confessional scholarship' criteria to 2021 publication outputs are presented in this 2021 Research and Scholarship Report. All 'research' (and almost all 'confessional scholarship') reported is in the field of Religious Studies (ASCED 091703). Summary data for 2016-2020 outputs based on these criteria were provided in Appendix 1 of the 2020 Research and Scholarship Report.

Appendix 1 of this report gives the research and confessional scholarship of ACT HDR supervisors whose primary academic affiliation is elsewhere. These are not counted in the ACT figures presented in this report.

The tables in Appendix 2 summarise the yearly outputs in both research and scholarship by publication type for 2016-2021.

The list of journals and publishers is provided in Appendix 3 and is updated as required by the Research Committee on the advice of its Research Publications Assessment Panel. The list is circulated to all faculty and HDR supervisors for their reference as they compile their research plans for 2021-2025, and <u>the updated list is available to faculty and HDR candidates via the ACT website</u>.

In Research there are four sub-categories: books \square , book chapters \square , journal articles \square , and refereed conference proceedings. In Confessional Scholarship there are seven sub-categories: books \square , book chapters \square , journal articles \square , refereed conference proceedings, edited books \cong , conference presentations \mathcal{Z} , and book reviews \mathcal{A} .



When refereed conference proceedings have been published as edited book volumes with an ISBN, as is usually the case in Religious Studies, individual contributions have been included in our count as book chapters – hence the reason for the zero values reported here (despite the greater values for this category in some other disciplines). Papers presented at conferences which have not yet been published are recorded as conference presentations. These are often revised and subsequently published as peer-reviewed journal articles or book chapters which are then categorised as research or scholarship, as appropriate.

In terms of Table 1, multiple authored items are only counted once. Scores in parentheses represent a weighting of five points per book (in accordance with common academic practice).

The following tables represent summaries of the 2016-2021 ACT Research and Scholarship database as at 24 August 2022. The criteria for classifying the 2021 research and scholarship outputs (p.1) were applied retrospectively to the previous data giving the aggregate figures. Research publications are all in the field of Religious Studies (ASCED 091703). As part of its process to improve the capture of research and scholarship outputs, the ACT inaugurated a quarterly reminder to contributors to update their submissions. The re-classification process and additional submissions have increased both research and scholarship numbers, particularly for 2016-17 where past records were incomplete. APPENDIX 3: Guide to ACT-estimated ERA Rankings

The Excellence in Research for Australia (ERA) evaluation does not rate individual journal articles or books or publishers but rates the overall output from an institution in a particular Field of Research (FoR). The rating is provided over broad fields (e.g. 50–Philosophy and Religious Studies) and narrow fields (e.g. 5005–Theology). A five-point rating scale is used, running from "well above world standard" to "well below world standard."

Nevertheless, to provide a guide to ACT researchers, the following classifications are given to indicate the likely ERA rating that an article in a particular journal or a book with a particular publisher would contribute to. The classification is not definitive—for example, the quality of a journal can change with time; university presses may publish both monographs (research) and textbooks (scholarship)—but serves as a guide to where ACT researchers should be aiming to publish their research.
